

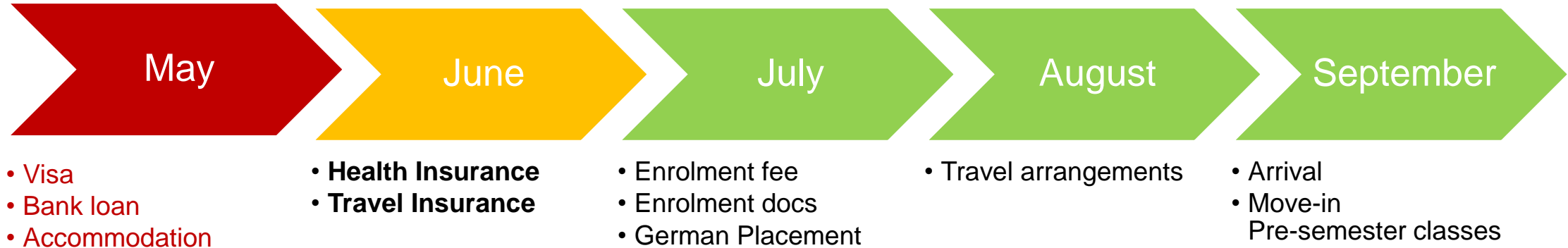

Visa, Enrolment and Arrival Time

FAQ

Q: Do I need an enrolment letter for my visa authorities?

A: No, because the winter semester has not yet started.

Q: Until when can I be enrolled, if my visa is delayed?

A: Enrolment is possible without visa. Arrival until:

- 08.09.24 – should be fine
- 14.10.24 – missed German and Technical Presemester classes / delay
- later – repetition of semester required

Q: Can I defer a semester, if I do not get my visa in time?

A: No, as we only offer the relevant pre-classes in September.

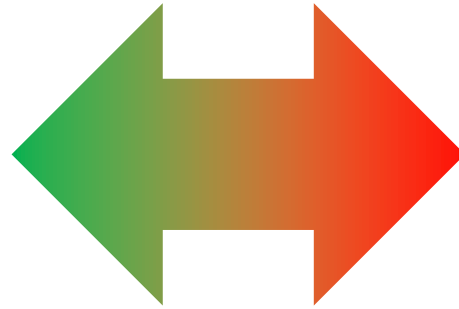

Health Insurance - A must have insurance



Germany has the world's oldest social health insurance system

- **1883 Health insurance**
- **1884 Accident insurance**
- **1889 Pension insurance** (originally disability and old-age insurance)
- **1927 Unemployment insurance**
- **1995 Long-term care insurance** (incorporated into health insurance)

The German Social Security System

- Statutory social insurance is the most important social security institution in Germany
- It is closely regulated by law and is organized by self-governing insurance institutions
- The contributions of the statutory health insurance companies are basically the same
- We work closely with the TK as the largest institution, providing special services for students
- But any statutory health insurance may be selected of course.
